Annual Enrollment Changes

- ❑ **Health** – Switch health plans
- ❑ **Vision** – Enroll in, cancel, add or drop dependents
- ❑ **Optional Life**
 - Premiums increasing
 - Enroll in or increase coverage up to \$50,000 without medical evidence (can also cancel or decrease coverage)
- ❑ **MoneyPlu\$**
 - Add or drop pre-tax premium
 - Enroll or re-enroll in flexible spending accounts with FBMC

With Medical Evidence

- Optional Life** – more than the guaranteed \$50,000
- Dependent Life - Spouse**
- Supplemental Long Term Disability**
- Long Term Care**

Important Information Regarding HMO Changes

Blue Choice HMO

- EIP will mail letters to all BlueChoice subscribers, advising them of the plan changes and premium increase for 2013
- Medicare-primary retirees, survivors and COBRA subscribers will be prompted to change coverage during annual enrollment
- Can switch to the SHP Medicare Supplemental Plan or cancel health coverage altogether
- If do not elect a new plan, coverage will be switched automatically to the SHP Medicare Supplemental Plan effective 1/1/2013

Important Information Regarding HMO Changes

CIGNA is not available in 2013

- EIP will mail letters to all CIGNA subscribers, advising them to elect a new plan for 2013
- If subscriber does not elect a new plan or cancel health during annual enrollment, his coverage will be switched automatically to the State Health Plan effective 1/1/2013
- Active employees and non-Medicare eligible retirees will be switched to SHP Standard Plan
